# Investment Opportunities

Antigua & Barbuda's Citizenship by Investment program requires investors to contribute to the National Development Fund in return for a citizenship and passport.

## **Contribution to the National Development Fund (NDF)**

The government has recently reduced the required contribution amount to only \$230,000 USD (family of 4)

### **Government Processing Fees (USD):**

- \$30,000 - Family of 4 (or less)
- \$10,000 - For each additional qualifying dependent

In addition, the following changes will apply for all investment options:

### **Due Diligence Fees (USD):**

- \$8000 - Main applicant
- \$5000 - Spouse
- \$4,000 - Dependents over 18 years and over

### **Passport Fees (USD):**

- \$300 - Each family member

### **NOTES:**

- Both parents must be fully dependent on the main applicant or spouse and living in the same household.
- Additional charges apply and all fees are subject to change at any time without notice.


# Benefits

- Fast Processing Time- Citizenship approval typically within 3–6 months.
- No Residency Requirement- No need to reside in Antigua & Barbuda; minimal 5-day visit within 5 years (currently suspended for dependents under 18).
- Visa-Free Travel-Access to 131+ countries including the UK, Schengen Area, Hong Kong, Singapore, and more.
- No Personal or Worldwide Income Tax- No tax on personal income, worldwide income, wealth, inheritance, or capital gains.
- Dual Citizenship Allowed - No need to renounce your current nationality.
- Family Friendly- Include dependent children up to 28 years old and dependent parents aged 58 and above.
- Simple Documentation- Limited number of documents required for the application process.
