





# Investment Opportunities

In exchange for a modest investment, the Commonwealth of Dominica offers citizenship to those who are seeking a second passport. The well regulated Dominica Economic Citizenship Program has been running since 1993, and is a significant revenue generator for local projects and programs.

## **Contribution to the Commonwealth of Dominica**

The minimum investment is just \$100,000 USD. Funds are then directed toward building schools, renovating hospitals, and/or promoting the offshore sector, including developing tourism, the agricultural industry, and/or the information technology industry.

Contributions to the Commonwealth are scaled as follows (USD):

- \$ 200,000 - Single Applicant
- \$ 250,000 - Main applicant and up to three qualifying dependants
- \$ 25,000 - Each additional dependant after family of 4 but under the age of eighteen
- \$ 40,000 - Each additional dependant after family of 4 but eighteen years of age or older

## **Due Diligence Fees (USD):**

- \$ 7,500 - Main applicant
- \$ 4,000 - Spouse
- \$ 4,000 - Dependents 16 years of age and above

In some cases, additional due diligence fees maybe required depending on current citizenship status and other personal circumstances.

## **Processing Fees (USD):**

- • \$ 1,000 - Government processing fee
- • \$ 250 - Certificate of Naturalization per person
- • \$ 1,200 - Expedited passport issuance per person

NOTE: Additional charges apply and all fees are subject to change at any time without notice

# Steps and Timeline

- **Initial Consultation:** The first step is a complimentary consultation with us where we explain all the different options available.
- **Preliminary Due Diligence :** Raizing Sovereign performs a preliminary due diligence, security check, before officially making any agreement as a guarantee that the applicant's record is clean from any case that the Citizenship by Investment Unit might reject his/her application for.
- **Agreement & Fees:** Fees include legal, due diligence, government and application processing fees.
- **Choose Property (Real Estate Option):** Once the property has been chosen the developer is notified to prepare a purchase and sale agreement.
- **Collect Documents & Submit File:** We will help obtain/translate and authenticate all necessary documents. A file is then prepared and submitted to the Citizenship by Investment Unit (CBIU), which usually takes approximately 10 business days from the date the file is prepared.
- **Wait for Approval:** Approximately 2-4 months.
- **Extra Documents:** The Citizenship by Investment Unit (CBIU) may request additional documents or information.
- **Approval:** Once approval has been granted, the applicant must complete all payments to obtain citizenship certificates within 60 days.
- **Passport:** After receiving the naturalization certificate, the process of issuing passports takes approximately 5-10 business days.

NOTE: Timeline is an estimate only, processing time depends on the complexity of each file.

# Required Documents

- Draft of application forms (provided by Raizing Citizen)
- HIV, blood, and urine test for all family members
- 12 month bank statement & bank reference letter
- Character reference letter
- Letter of recommendation from school/university for children 12 - 18 years
- Employment confirmation letter (if main applicant is an employee)
- Recent utility bills, tenancy contract or bank statement showing full name and address
- Sworn affidavit of no criminal record by parent for children 12 - 15 years old
- Police certificates from country of birth and every country you have lived in for more than 6 months over the past 10 years. Main applicant, spouse, dependents & dependent children 16 years and above need to provide police certificates
- Signed power of attorney
- Signed affidavit of financial support for children 18-30 years old (notarized)
- 4 sets of signed property purchase agreement (real estate investment option)
- Signed client agreement
- Updated CV from main applicant
- Completed questionnaire for all family members

# Certified Copies

- Colored Passport copies for all family members (with valid residence visa page, if applicable)
- Birth Certificates for all family members
- Marriage Certificate
- Divorce documents (if applicable)
- Custody documents (notarized, if applicable)
- Personal ID or national ID for all family members
- Driving license (if applicable)
- Education Certificate for the main applicant, spouse, and dependents with a university degree
- Business registration/license AND memorandum of association issued by the local government confirming the registration of the business (if self-employed) 10. Military certificate or documents (if applicable)

**NOTE: The government of the Commonwealth of Dominica may request additional documents and/or information not listed above.**
