# Investment Opportunities

## 1. National Transformation Fund (NTF) Contribution

Make a non-refundable donation to Grenada's National Transformation Fund.

### Minimum Contribution:

- USD 235,000 - Main Applicant and up to 3 dependents (except for siblings, parents and grandparents aged 55 and under)
- USD 25,000 - Each additional dependent after family of 4 (except for siblings, parents and grandparents aged 55 and under)
- USD 50,000 - Each parent, grandparent aged 55 and under
- USD 75,000 - Each sibling

## 2. Approved Real Estate Investment

- Invest in a government-approved real estate project.
- Minimum Investment: \$235,000 USD (shared investment) — must invest in a project valued at \$440,000 USD total.
- Property must be held for a minimum period as required by the program.

### Government Fees (USD)

- \$50,000 — Government fee for a family of up to four persons.
- \$25,000 — For each additional dependent child, parent, or grandparent.

### Processing and Application Fees:

- \$1,500 - Application fee for Citizenship \ by Investment (per person)
- \$1,500 - Processing fee per person (except dependent children under 18—their fee is \$500/person)

### Due Diligence Fees (USD):

- \$5,000 USD - Principal applicant
- \$5,000 USD - Spouse
- \$5,000 USD - Dependents 18-30 years old
- \$5,000 USD - Dependent parents and/or grandparents


# Steps and Timeline

- 1. Initial Consultation** — Discuss options and eligibility.
- 2. Preliminary Due Diligence** — Background check to ensure clean record.
- 3. Agreement & Fees** — Sign agreements and pay initial fees.
- 4. Choose Investment** — Select property or NTF contribution.
- 5. Document Collection** — Gather, translate, and notarize all documents.
- 6. Application Submission** — Submit the file to Grenada's Citizenship Unit.
- 7. Wait for Approval** — Takes approximately 2–4 months.
- 8. Approval and Payment** — Make full investment and pay remaining fees.
- 9. Citizenship Certificate Issuance** — Within 60 days after final payments.
- 10. Passport Issuance** — Receive Grenadian passport within 5–10 business days.

# Required Documents

- Draft application forms
- HIV medical reports
- Bank statements and reference letters
- Character reference letter
- Employment letter (if employed)
- Proof of residential address (utility bill, lease, or bank statement)
- Police certificates (for applicant and dependents 16+ years)
- 8 passport-size photos for each family member
- Signed power of attorney and affidavit of financial support
- Signed property purchase agreements (for real estate option)
- Updated CV (for main applicant)
- Personal ID copies, birth certificates, marriage/divorce documents
- Educational certificates
- Business registration documents (if self-employed)
- Military certificate (if applicable)
