# Investment Options

Providing the only Citizenship by Investment (CBI) program of its kind in the Asia Pacific Hemisphere, Vanuatu provides investors with an opportunity to acquire a citizenship and a passport through a government donation in a stable, safe and peaceful country.

Contribution to the Development Support Program (DSP): The Development Support Program (DSP) has been established in 2017 to provide honorary citizenship to foreigners who make certain economic contributions to the government.

Contributions to the (DSP) program are scaled as follows (USD):

- \$130,000 USD - Single applicants
- \$150,000 USD – Main applicant and spouse
- \$165,000 USD – Family of 3 (Main applicant, spouse, & 1 child)
- \$180,000 USD – Family of 4 (Main applicant, spouse, & 2 children)
- \$15,000 USD – For each additional qualifying dependent

## NOTES:

- The above fees include all government and agent processing fees, filing, certificate and passport production.
- Additional charges apply and all fees are subject to change at any time without notice.

# Steps and Timeline

## **Initial Consultation**

The first step is a complimentary consultation with us where we explain all the different options available.

## **Preliminary Due Diligence**

Raizing Citizen performs a preliminary due diligence, or security check, before officially making any agreement as a guarantee that the applicant's record is clean from cases that the Citizenship by Investment Unit might reject his or her application for.

## **Agreement and Fees**

Fees include legal, due diligence, government and application processing fees.

## **Government Pre-Approval**

This stage involves the collection of preliminary documents for a Vanuatu Government background check on the applicant. This process takes approximately 7 to 10 business days.

## **Collect Documents & Submit File and Investment**

Upon approval, we will help obtain, translate and authenticate all necessary documents for the applicant. Along with the remaining investment, a complete file is then prepared and submitted within 10 business days to the citizenship commission.

## **Wait for Approval**

This process takes approximately 2 to 3 months. After the citizenship commission approves the application, an Agreement in Principle (AIP) is issued.

## **Make Oath & Receive Passport**

Once approval has been granted, the applicant must appear at a Vanuatu Consulate or Government Office to participate in the Oath of Allegiance ceremony upon which they will be granted their citizenship and receive his or her Vanuatu passport.

**NOTE: Timeline is an estimate only, processing time depends on the complexity of each file.**
